Dear Mr Kermode

We write further to your request which was received on 4 February 2022 and which states:

"In the IOM, Covid deaths are recorded as those where Covid-19 is mentioned anywhere within the death certificate.

There have been 73 Covid deaths officially recorded on the IOM from March 2020 to 2nd February 2022.

Please can you confirm the following:

- 1. How many of such 73 death certificates are where only Covid-19 is mentioned on the death certificate (i.e. no mention of any other disease or condition or contributory condition)?
- 2. How many of such death certificates are where Covid-19 is stated as being the main cause of death (1a on the death certificate)?
- 3. How many of such 73 death certificates are where Covid-19 is mentioned not as the main cause of death but as another condition or disease or as a contributory condition?
- 4. How many of such 73 deaths were of persons who were not vaccinated in any way against Covid-19 (i.e. had not had a first or second or booster jab)?
- 5. Does the IOM Government definition of double vaccinated mean from the actual day of the second vaccination or from a later date e.g. 2 weeks hence? Thank you"

Our response:

Question 1: How many of such 73 death certificates are where only Covid-19 is mentioned on the death certificate (i.e. no mention of any other disease or condition or contributory condition)?

While our aim is to provide information whenever possible, in this instance the Manx Care is unable to provide the information that you have requested. This is in line with Section 11(3)a of the Act, as a practical refusal reason applies; namely we do not hold or cannot, after taking reasonable steps to do so, find the information that you have requested. Manx Care do not hold death certificates and consequently the cause of death.

- 2. Whether we are justified in refusing to give you the information requested.

In response to an application for review, the Information Commissioner may, at any time, attempt to resolve a matter by negotiation, conciliation, mediation or another form of alternative dispute resolution and will have regard to any outcome of this in making any subsequent decision.
