


**Have 1.7 million people in Europe been harmed by

As the Covid-19 pandemic developed during the spring of 2020, vaccines were hastily produced by pharmaceutical companies and given emergency use authorisation by governments around the world who also granted legal indemnities to these companies against civil action for vaccine harm.

The authorities repeatedly extol the success of their Covid-19 vaccine rollouts but is there another side to this story namely have any recipients been harmed or even died as a result of being jabbed and if so, how many?

Some of us may have anecdotally heard about a family member, friend or colleague who has suddenly had a heart attack or stroke after Covid vaccination and perhaps

this helps explain the tailing off and diminishing rate of take up from first dose through to second dose and various boosters, but are there any official statistics on this issue?

The UK Government's Medicines and Healthcare Products Regulatory Agency (MHRA) monitors the safety of Covid-19 vaccines through its **YELLOW CARD** scheme.

This is a scheme whereby members of the public and health professionals can report suspected side effects.

Up to 15th June 2022, there have been 245,614 **YELLOW CARD** reported adverse reactions to the AstraZeneca vaccine, 171,590 to the Pfizer and 39,514 to the Moderna.

This gives a massive total of **456,718** for the UK.

Any **YELLOW CARD** reports from Isle of Man residents form part of these UK statistics.

The adverse reactions include Bell's Palsy, blood clotting, anaphylaxis (severe allergic reaction) and Myocarditis (inflammation of heart). To take another example, a total of 51,298 menstrual disorders were reported including heavier than usual periods, delayed periods and unexpected vaginal bleeding.

It is also worth noting that each **YELLOW CARD** may in fact include multiple symptoms so that the total number of reactions may be much greater than the number of individual **YELLOW CARDS**. For instance, the 245,614 **YELLOW CARDS** for the AstraZeneca vaccine actually comprised 870,093 suspected individual symptoms.

In the European Union, the European Medicines Agency (EMA) monitors the safety of Covid-19 vaccines. As at 29th May 2022, the EMA data showed that there had been 786,983 suspected adverse reactions to the Pfizer Covid-19 vaccines, 276,697 to the AstraZeneca, 219,135 to the Moderna and 50,410 to the Janssen.

This is an overall truly shocking total reported side effects to Covid-19 vaccines in the EU of **1,333,225**.

Obviously, these figures are only for the EU and do not include the rest of the world. For example, in the USA, similar Covid-19 safety data is provided by the Centers for Disease Control and Prevention (CDC) through its Vaccine Adverse Event Reporting System (VAERS).

The official statistics quoted above reveal an astounding total for the UK and EU combined of **1,789,943** currently reported incidents of adverse reactions/harm linked to Covid-19 vaccines.

And do remember that these are only the reported incidents, possibly the tip of the iceberg.

Despite this, the vaccine rollout continues.

And so perhaps the more pertinent and disturbing question should therefore be not whether 1.7 million people in Europe have suffered harm as a result of Covid-19 vaccines but why is that the media turns a blind eye to this data and the statistics are not prominently publicised by governments?

Surely, this is a matter of considerable public interest and highly relevant to the issue of informed patient consent.
