We write further to your request received on 15 November 2022 which states:

"Please can you confirm the following:

- 1. For the financial year April 2021 to April 2022, what was the total remuneration (in salaries etc) paid to executive board members of Manx Care (including the CEO)?
- 2. For that financial year what was the total remuneration (including all fees) paid to non-executive board members of Manx Care?

Please note that we originally requested this information from Manx Care but in a FOI reply dated11.11.22 it stated that it did not hold this information and suggested we contact the Cabinet Office.

Our response to your request is as follows:

1. For the financial year April 2021 to April 2022, what was the total remuneration (in salaries etc) paid to executive board members of Manx Care (including the CEO)?

We can confirm that the total remuneration (in salaries etc.) paid to executive board members of Manx Care totalled £654,305.75 in the financial year 2021-2022.

2. For that financial year what was the total remuneration (including all fees) paid to non-executive board members of Manx Care?

Please note that we originally requested this information from Manx Care but in a FOI reply dated 11.11.22 It stated that it did not hold this information and suggested we contact the Cabinet Office.

For the financial year 2021-2022, we can confirm that the total remuneration (including all fees) paid to non-executive board members of Manx Care totalled £138,879.71.

In response to an application for review, the Information Commissioner may, at any time, attempt to resolve a matter by negotiation, conciliation, mediation or another form of alternative dispute resolution and will have regard to any outcome of this in making any subsequent decision.
