Dr Fauci on PCR testing for Covid-19 transmission risk : "If you get a cycle threshold of 35 or more, the chances of it being replication competent are miniscule. Somebody comes in and they repeat their PCR and it's a 37-cycle threshold, but you almost never can culture virus from a 37-theshold cycle. So, I think if somebody does come in with 37, 38 even 36, you gotta [sic] say it's just dead nucleotides, period."

(A Freedom of Information reply dated 17th February 2021 disturbingly confirmed the sensitivity/cycle threshold of PCR testing on the Isle of Man is **40** cycles).

In December 2022 Dr Anthony Fauci, the Chief Medical Adviser to the US President, officially retires.

Dr Fauci advised US Presidents Trump and Biden during the Covid-19 pandemic.

A controversial figure, Dr Fauci has been praised by many in the Democratic party for his medical advice which they say saved lives during the health emergency.

For many others, however, particularly in the Republican Party, Dr Fauci has been sharply criticised for being capricious, anti-libertarian and politicising medical science.

Initially, Dr Fauci described Covid-19 in February 2020 as being a low risk to the American public and did not recommend that immediate social distancing or stay-at-home measures be introduced.

In March 2020, he notably said that, *"Right now in the US, people should not be walking around with masks"*.

However, he subsequently flip-flopped and became the principal architect and cheerleader of draconian lockdown measures, social distancing, PCR testing, face mask wearing and later the use of Covid-19 vaccine mandates for entry to premises and businesses.
