Covid vaccine harm Petition presented at Tynwald Hill, Ellan Vannin.

The Manx Parliament, Tynwald, holds an open-air sitting every year on 5th July, in the village of St.Johns.

Tynwald means "meeting place" in Norse and the name originates from the period when the Vikings ruled the Isle of Man and the Scottish Isles creating a kingdom known as Sodor and Mann.

The first recorded *Tynwald* was in 979 AD and the Millennium of *Tynwald* was celebrated in 1979, when amongst other events and festivities, a replica Viking boat, named **Odin's Raven**, was built and sailed from Trondheim in Norway, down the West coast of Scotland, arriving on Peel beach on the Isle of Man on 5th July 1979.

At the annual open-air parliamentary sitting, the short title of each new Manx Law is read out by the Island's 2 senior **Deemsters** (judges) in Manx Gaelic and English, a procedure known as promulgation.

The outdoor session also provides an opportunity for Islanders to present what is known as a **Petition for Redress of Grievance**.

This is an ancient right of Manx citizens and a Petition should raise a matter of public interest and requests that a committee of *Tynwald* be set up to consider the content of the particular grievance.

An important Petition presented this year was by Mrs Natalie Birchall and her two friends Miss Nikola Brindley and Mr Stephen Wotton.

Their Petition raises serious concerns in relation to Covid-19 vaccines (including AstraZeneca, Moderna and Pfizer).

This significant Petition calls for a committee to be set up to consider and report back to *Tynwald* on the merits and remit of establishing an independent inquiry/review into the ethics, necessity and safety of Covid vaccines on the Isle of Man and stopping further Covid-19 vaccines in the interim.

It is hoped that a member of the House of Keys (MHK) or a member of the Legislative Council (MLC) will pick up the Petition and that the issues are properly scrutinised in the Manx Parliament.

Obviously, any member of the electorate can contact their local MHK and ask if he/she would be interested and willing to assist with this Petition. We would encourage you to do so.
