

Dramatic decline in Covid vaccination uptake



Moderna's Covid booster – unnecessary and risky?

We recently submitted a Freedom of Information request to *Manx Care* about Covid-19 vaccination uptake on the Isle of Man.

Covid-19 vaccination has been offered on the Island since January 2021.

The Island is a largely self-governing Crown Dependency with a population of 84,069 (as at 30th May 2021 Census).

Covid vaccines were initially offered to IOM residents aged 18 or over before being broadened to every person aged over *6 months old*.

The first and second doses were offered in early 2021, the third in autumn 2021, the fourth in spring 2022, the fifth in autumn 2022 and the sixth in spring 2023.

A seventh dose is currently being offered this autumn to Island residents (supposedly in relation to the new Covid variant named *Pirola*).

In its FOI response dated 20th September 2023, *Manx Care* revealed some quite remarkable statistics as follows:-

- i) 1st dose – 71,849.
- ii) 2nd dose – 68,716.
- iii) 3rd dose – 53,715.
- iv) 4th dose – 25,541.
- v) 5th dose – 8,740.
- vi) 6th dose – 6,245.

In other words, from a high of 85.5% of the entire population receiving one dose of a Covid vaccine, there has been a very steep decline to a low of only 7.4% of the population accepting a sixth dose.

Why has there been such a dramatic collapse in Covid vaccine uptake?

Is it because of one or more of the following reasons:-

1. Many people now fundamentally understand that Covid-19 (and variants) is just another respiratory illness like seasonal flu, causing only mild flu-like symptoms for most people and is not the invisible, terrifying and lethal threat to every man, woman and child as first asserted by governments.
2. In other words people now know that Covid-19 was only ever a serious risk to the elderly or clinically vulnerable (as they are every year from flu), but not a life threatening risk to anyone else.
3. Citizens have lost faith in the media and public health messaging and believe that coercive and highly alarmist information was presented by governments about Covid-19.
4. Individuals now appreciate that Lateral Flow Tests (LFTs) and PCR testing for Covid has been discredited as being unreliable and inaccurate. For example, Gate Acre School, Belle Vale, Liverpool had to write to parents in June 2021 to warn them that children were bunking off school by obtaining false positives on LFTs. Apparently, crafty kids had somehow worked out that by placing *Coca-Cola* or apple juice (or something with an acidic pH) droplets on the LFT device, a positive result (2 red lines) would be displayed. The canny youngsters could then skive off school for 5 days.
5. People now know that routine testing of healthy **asymptomatic** individuals is wholly unnecessary and indeed counterproductive, leading to unwarranted time off work and school.
6. The gruesome and shocking truth has gradually seeped out through word of mouth, social media or personal research that the AstraZeneca Covid vaccine (which was the first dose vaccine administered to 63% of IOM residents) has as its active ingredient a version of a common cold virus taken from a **Chimpanzee** (as stated on the AstraZeneca product leaflet).

7. Such common cold virus from a Chimpanzee was **genetically modified**.
8. AstraZeneca states on their own website that its Covid vaccine contains Genetically Modified Organisms (GMOs).
9. It has alarmed and distressed many people to find out that the AstraZeneca vaccine uses a host cell line called HEK-293, which are clones of cells taken from the kidney of an **aborted human foetus** (HEK stands for Human Embryonic Kidney).
10. Importantly, citizens now realise that some doctors did not provide sufficient information to enable patients to give true and informed consent, as required under medical ethics such as the *Nuremberg Code 1947*.
11. In other words, it is now understood that there is a professional and ethical obligation on those administering the vaccine to provide adequate information and that it is not up to citizens to, "*look up on the internet themselves*" (as ridiculously stated by one IOM government minister) if they wanted more information on Covid vaccines.
12. The UK Government's *Medicine and Healthcare Products Regulatory Agency* (MHRA) monitors the safety of Covid-19 vaccines through its *Yellow Card* scheme. This is a scheme whereby members of the public and health professionals can report suspected vaccine side effects. A similar reporting scheme is run by the *European Medicines Agency* (EMA). As at 15th June 2022 there had been a staggering **1,789,943** (nearly 1.8 million) officially reported incidents of adverse reactions/harm linked to Covid vaccines in the UK and the EU.
13. In the USA, the *Vaccine Adverse Event Reporting System* (VAERS) monitors vaccine safety. Covid vaccine side effects have been recorded at levels comparable to that in the EU.

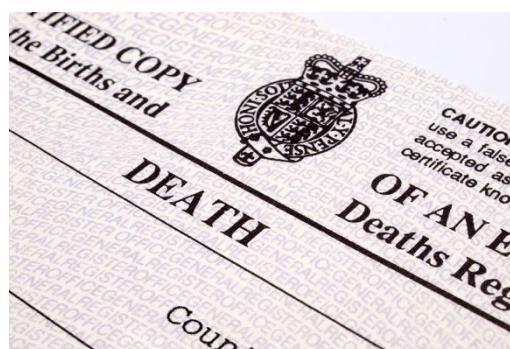
14. It is also interesting to note that the approximate 1.8 million reported Covid vaccine adverse reactions in the UK and the EU is the figure as at **15th June 2022**. Unfortunately, since November 2022 both the MHRA and the EMA have changed their data recording systems so that an overall cumulative total is no longer displayed. Whether or not this is a deliberate attempt to conceal the true scale of reporting, it regrettably means that the overall cumulative statistics are now almost impossible to ascertain.
15. Is this data obfuscation a glaring example of SHOULDINFORMATION (this relatively new word is defined as: "*Information which a person or body already has and which should be revealed in the public interest but is deliberately not disclosed or prominently publicised*" – see link below to our article **Shouldinformation and the Rocky Horror Covid Vaccine Show**)?

16. The official *Yellow Card* statistics also give a breakdown of the number of reported adverse reactions per each Covid vaccine (AstraZeneca, Moderna, Pfizer and Novamax). Perhaps unsurprisingly, AstraZeneca tops the list.
17. The tragic serious side effects reported include strokes, major heart attacks, severe allergic reactions, deep vein thrombosis and menstrual problems such as unexpected vaginal bleeding.
18. In addition, as at 31st July 2022 there had been a horrifying official total of **26,593** reactions with reported fatal outcomes i.e. **deaths** shortly after the Covid-19 vaccination in the UK, EU and the USA (2,213 in the UK, 10,992 in the EU and 13,388 in the USA).
19. For the Isle of Man, a UK FOI reply dated 9th May 2022 revealed that there had been a massive total of **1018** *Yellow Cards* from the Island. Disturbingly, this equates to 1.4% of the 71,849 IOM persons vaccinated, reporting side effects via the *Yellow Card* procedure (that is 1.4 persons in every 100).
20. The breakdown of that overall IOM total 1018 *Yellow Cards* was AstraZeneca 625, Moderna 86 and Pfizer 307.
21. A Facebook group for those potentially harmed by Covid vaccines on the IOM has over 800 members and a *Petition for Redress of Grievance* concerning Covid vaccines was presented at Tynwald Hill (open-air sitting of the Manx Parliament) on 5th July 2023.



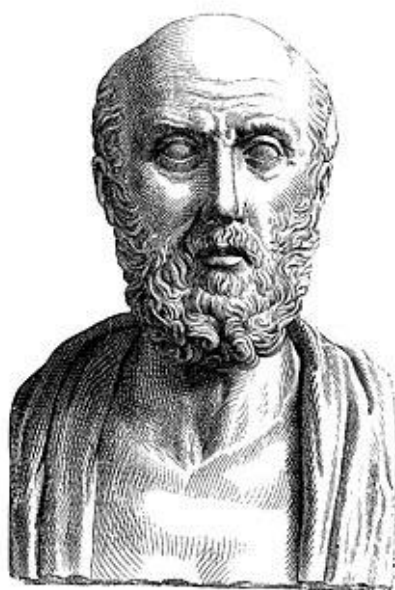
Manx citizens exercising their ancient right to petition.

22. It is also worth noting that the *Yellow Card* reported side effects are only the officially recorded statistics. How many more persons suffered adverse reactions but did not know that the *Yellow Card* scheme even exists?
23. Some people have quite understandably been scandalised by the calamitous scale of human harm (as officially recorded) linked to Covid vaccines and this suffering is not accepted as being entirely coincidental.
24. Accordingly, some right-thinking members of the public (who, it is worth pointing out, have had all the usual childhood vaccinations such as for Polio, tetanus and diphtheria and are not “anti-vax” per se) have legitimately concluded that Covid vaccines are potentially more dangerous than Covid-19 itself.
25. It is now widely recognised that there is a clear distinction between deaths *from* Covid versus deaths *with* Covid. The media for many months reported Covid deaths as being where a person had died within 28 days of a positive Covid test, even if a person’s main cause of death had been something else and entirely unconnected (for example getting run over by a bus).



Have there really been 231,683 deaths from Covid in the UK?

26. In this regard, it was most regrettable that the IOM General Registry refused to provide data in response to our FOI enquiry dated 18th February 2022. This was a simple request for information as to the number of death certificates which had Covid recorded as the **main** cause of death and secondly the number of death certificates where Covid was not mentioned as the main cause of death but only a **contributory** condition.
27. However, it is now openly known that many of those deaths reported as Covid deaths were falsely reported as Covid fatalities because persons had in fact died for other reasons, with Covid not recorded on the death certificate as the main cause of death. In other words, it is acknowledged that Covid death statistics were misleading and exaggerated.
28. It is now better understood that **PREVENTATIVE** measures can significantly reduce the seriousness of any respiratory illness including Covid-19. *Hippocrates*, a wise physician from Classical Greece is traditionally referred to as the Father of Medicine.



Hippocrates is attributed to have said, "Let food be your medicine and medicine be your food".

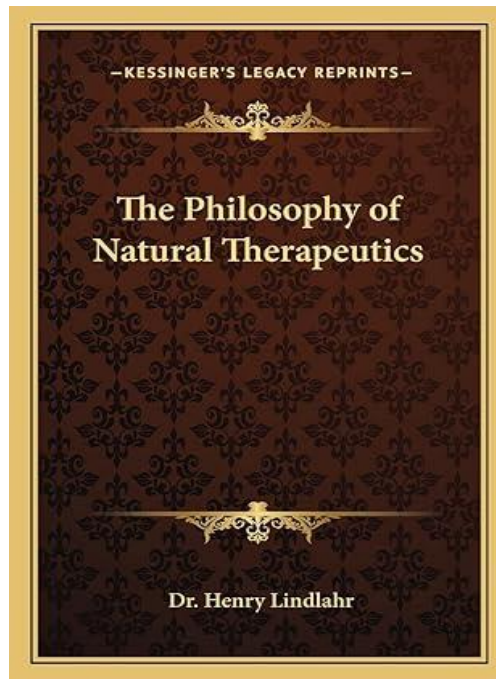
29. A healthy and positive lifestyle includes drinking a sufficient amount of clean water, taking daily outdoor exercise and moderate amounts of sunshine, getting adequate sleep, eating plentiful fruit and fresh vegetables, vital wholegrains and nuts, oily fish and fermented foods whilst at the same time reducing stress, consumption of alcohol, salt, refined sugars, processed food and stopping smoking.
30. Another preventative treatment is reducing consumption of red meat. The *British Medical Journal* featured an informative study dated 7th June 2021 by Dr Casey Rebholz (of John Hopkins Bloomsbury School of Public Health, Baltimore, USA) and others which considered the relationship between

plant based diets and Covid-19 severity. This important study showed that participants across 6 countries who followed a mainly plant based diet had **73% lower** odds of developing moderate to severe Covid-19 severity compared to those who did not follow this diet.

31. Similarly, residents have a better understanding that **TREATMENTS** are available to properly deal with Covid symptoms, without resorting to vaccination. Covid symptoms such as a sore throat, tiredness, high temperature, achiness and phlegm are unpleasant but entirely treatable.
32. Traditional remedies which have stood the test of time include bed rest, fasting or intermittent fasting, fresh air (for example at the former TB sanatorium outside Ramsey called *Cronk Ruagh*, windows were left open all day, whatever the weather, and patients were wheeled outside to partake of fresh air), eating lightly (for instance consuming soups such as chicken or vegetable broths), taking sensible dosages of vitamin C and D and adopting therapies such as the *Father Kneipp* hydrotherapy as used in many German spas (hot and cold showers and use of herbal infusions).
33. The Dr Peter McCullough **Early Treatment Protocol** includes a multidrug anti-viral therapy incorporating vitamins C & D, Zinc and Quercetin plant extract. Dr McCullough estimated that over 50% of Covid related deaths in the USA could have been avoided if such treatment Protocol had been adopted by the authorities.
34. Similarly, there is the Front Line Covid-19 Critical Care Alliance (FLCCC). The Journal **WHAT DOCTORS DON'T TELL YOU** states that FLCCC is, "A coalition of doctors from multiple fields who have helped millions of people and thousands of other doctors to prevent Covid and treat Covid and help patients with long Covid and mRNA vaccine injury".
35. It is also now widely accepted that Covid vaccines do not stop the recipient developing Covid or becoming ill from Covid. There are many people who have developed Covid multiple times despite being vaccinated and have therefore lost faith in the effectiveness of the vaccine. I personally know of a colleague who has apparently had 3 bouts of Covid, despite being repeatedly jabbed.
36. Equally, it is now known that Covid vaccines do not stop the spread of the illness to other people. In effect, a fully vaccinated person can spread the illness to others. Hence, there have been seemingly puzzling outbreaks of Covid on cruise ships of fully vaccinated passengers and even at an extremely remote South Pole Research Centre staffed by fully vaccinated scientists.
37. In this regard it was disappointing that the main stream media did not give proper coverage to important research published in the *Lancet Infectious Diseases Journal* in October 2021, namely that double vaccinated persons could transmit the Covid virus just as much as the unvaccinated.

38. In fact, many persons no longer even accept the correct use or definition of the term vaccine for Covid vaccines. For example, to the ordinary person in the street, a vaccine is understood to prevent a person from developing a particular illness ever again. But what sort of vaccines are so-called Covid vaccines when they have to be administered or boosted 7 times in less than 3 years?
39. It is now obvious that much of the government and established media messaging around Covid was unjustifiably based on **fear**. Consider for instance the disgracefully cynical messages sent by the Health Secretary Matt Hancock in December 2020 suggesting that a so-called new Kent variant could be publicised specifically to scare people into complying with government requests.
40. Leaked *WhatsApp* messages include the following Machavellian exchange on 13th December 2020. Matt Hancock: "**We frighten the pants off everyone with the new variant**". Civil Servant replies "Yep, that's what will get proper behaviour change". Matt Hancock contemptibly responds: "When do we deploy the new variant?" The very next day, 14th December 2020, Mr Hancock announced that a new Covid variant (the Kent variant) had been identified.
41. Citizens now regard the labels "*Covid-19*", "*Kent*", "*Omicron*" and "*Pirola*" as being nothing short of laughable.
42. Equally, people are now savvy about the repugnant propaganda war which was waged during the pandemic against those who questioned lockdown, face mask wearing and the Covid vaccine roll out. Consider, for example, the surreptitious **Counter Disinformation Unit** (CDU). This is a secretive UK government body which monitors individuals such as journalists, politicians and activists and takes counter action by promoting the government agenda. The CDU also insidiously refers individuals to social media companies such as Facebook and Twitter with the aim of removing content deemed harmful to government messaging.
43. Of particular concern is the recent revelation at the UK Covid Inquiry that documents submitted by civil servants show that the security services such as *MI6*, *MI5* and *GCHQ* work closely with the CDU.
44. One example of the menacing activities of the CDU is in relation to the Green Party MP Caroline Lucas. Miss Lucas discovered via a *subject access request* that she had been red flagged by the CDU for her alleged "vaccine hesitancy" simply for arguing that booster vaccines should be sent to countries with shortages. Miss Lucas has called for an inquiry into the work of the CDU stating, "*The right of citizens to share entirely valid and objective criticisms of government ministers without fear of the consequences is a cornerstone of our democracy and must be protected*".

45. However, the CDU remains in being and continues with its sinister and clandestine surveillance work.
46. A similar shadowy government body was the **Rapid Response Unit** (RRU). This was an agency created to quickly identify trends in the media and create summaries on topics which were being reported in the press. Individuals would be specifically named in the reports. One sneaky example was a report on Andy Burnham, Mayor of Manchester, who criticised local lockdowns during the Covid pandemic and was referred to the Cabinet Office by the RRU for appraisal.
47. In another malevolent example of overreach, the UK Government recently apologised to **Talk TV** presenter Julia Hartley-Brewer after she was named in a vaccine hesitancy report from the RRU. Remarkably, the Government admitted that this report had even been shared with US counter-terrorism officials.
48. Thankfully, the sly Rapid Response Unit was disbanded in August 2022.
49. Miss S. Carlo, a director of *Big Brother Watch* rightly commented that, "*contrary to their stated aims, these government truth units are secretive and harmful to our democracy*".
50. All of those authoritarian messaging entities have now been exposed as being nothing less than the **enemies of truth**.
51. Many individuals have acquired natural resistance and strength arising from exposure to previous respiratory illnesses.
52. It may sound counter intuitive but there are some persons who believe that a respiratory illness is a positive thing, a cleanse which eliminates toxins therefore leading to improved health. For example, many naturopaths know from personal experience that colds and flus are a healing crisis in which the body raises its temperature to thin the lymph and produces mucus in order to eliminate toxicity.
53. Accordingly, it is understood that for sufficiently robust persons (not the frail or clinically vulnerable), a natural cleanse can ultimately leave the body stronger, healthier and more resilient. For example, a well known book "**Philosophy of Natural Therapeutics**" by the late Henry Lindlahr MD is widely regarded as a seminal work on naturopathic principles and espouses the benefits of a healing crisis.



The power of healing is within.

54. People are now more widely aware that all Covid vaccines initially received only *emergency use authorisation* from government. This means that they were rushed through or fast-tracked and did not go through the usual full clinical safety trials, which ordinarily take several years of testing.
55. In addition, evidence has emerged that Covid vaccines were not initially tested for viral *transmission* or *spread*. For instance, Ms Janine Small, Pfizer's president of international developed markets, admitted in an EU Parliament hearing on 11th October 2022 that the company's Covid vaccine had not been tested for preventing transmission. Apparently this was because they had not been asked by the US Food and Drug Administration to assess the transmission question in the original trials of the vaccine.
56. It is also worth noting that the vaccines were not initially tested on the elderly or vulnerable, only the healthy.
57. Additionally, citizens are cognizant that the so-called **mRNA** technology used in the Pfizer and Moderna Covid vaccines is based on relatively new and largely experimental science.
58. According to the pharmaceutical companies, mRNA vaccine technology uses encoded molecules called *messenger RNA* (mRNA) which aim to produce an immune response in the body.
59. These mRNA vaccines must be stored at very low temperatures e.g. the Pfizer Covid vaccine has to be stored at not less than minus 60°C. A concern which has been expressed about mRNA vaccines is that the encoded molecules enter into the very nucleus of human cells and the long term consequences of this are not fully known (aside from the immediate suspected harm evidenced in the *Yellow Card* reported adverse reactions).

60. Parents better understand that the risk of Covid to their children is negligible and therefore that child vaccination is not necessary (disturbingly, babies as young as **6 months** old are being Covid jabbed, using two doses of Comirnaty r3 vaccine, with parental consent).

61. There is very clear and extensive evidence that the Covid lockdown of society caused catastrophic indirect consequences such as tens of thousands of business closures, chronic delays in medical diagnosis and treatment, the dramatic rise in housing evictions and domestic violence, significant delays to criminal trials, serious impact on public finances and national debt, the devastating interruption to children's education and profound impact on mental health which far, far outweighed any good arising from lockdown.
62. In other words, many citizens are absolutely fed up and sickened by the whole Covid debacle and do not want anything more to do with Covid or indeed Covid vaccines.
63. The Moderna booster (or so-called "SpikeVax Bivalent Original/Omicron" used from autumn 2022) was only initially tested on **437** participants prior to distribution. In addition, the MHRA only granted authorisation under a so-called *conditional approval* scheme. The MHRA also stated that no data was available in respect of the safety and efficiency of the SpikeVax Bivalent Original/Omicron in children. Moreover, **no interaction** studies had been performed in respect of the administration of SpikeVax (original) or Spike Vax Bivalent Original/Omicron with other vaccines (whether Flu or other Covid vaccines such as AstraZeneca).
64. It is also noted from the MRHA that Moderna's SpikeVax Bivalent Original/Omicron vaccine had *not* been tested on pregnant female humans but had been tested on **female rats** "*By the intramuscular route on four occasions: 28 and 14 days prior to mating and on gestation days 1 and 13. There were no vaccine related adverse effects on female rats' fertility, pregnancy, embryo foetal or offspring development or postnatal development*".
65. The *Pfizer* booster submitted for approval to the US Food and Drug Administration in August 2022 had only been tested on **mice** at that stage.
66. Citizens now realise that the introduction of so-called mandatory Covid vaccine passports for international travel was simply a discriminatory and coercive tool used by governments to increase vaccine uptake. We all know someone who was vaccinated just to go on a foreign holiday or to see a relative abroad.

67. Equally, there are many people who reluctantly agreed to be vaccinated after being told that it was necessary in order to visit elderly relatives in residential/care homes. However, as stated above, this requirement was unjustified because fully vaccinated care home staff and visitors could spread the respiratory illness just as readily as unvaccinated visitors.
68. The resentment some people feel at being pressurised into Covid vaccination in such circumstances is therefore entirely understandable.
69. Of course, the other aspect of the authorities' *carrot and stick* approach to vaccine uptake is the extraordinary Government backed inducements offered to those willing to be Covid vaccinated. For example, in Oregon, USA, the State ran a draw just for vaccinated students with the chance to win 5 college scholarships worth \$100,000 each. Meanwhile in Washington State, under its laughable "**Joints for Jabs**" promotion, anyone over 21 could receive a free pre-rolled cannabis joint if they were vaccinated. In the UK, *Asda* bizarrely offered £10 vouchers off their clothing brand George to those who agreed to be Covid vaccinated and *Deliveroo* gave out thousands of £5 vouchers to the vaccinated.
70. With the passage of time and in the clear light of day, people are now properly asking themselves why was it necessary to offer any inducements to be vaccinated. If the vaccines were safe and effective, why on earth offer any incentives? Quite simply, people SMELL A RAT.
71. People are astounded by how much money the pharmaceutical companies are making from Covid vaccines. For example, Pfizer sold its Covid vaccine to the UK Government for £18 a dose for the first 100 million doses rising to £22 a dose thereafter. The vaccine cost just £4.94 to produce.
72. According to company accounts presented by chief executive officer Mr Albert Bourla, Pfizer sold an astronomical **\$35 billion** worth of Covid vaccines worldwide in 2021 and **\$37.8 billion** in 2022.
73. However, sales for 2023 are projected to fall by two thirds to around \$13.5 billion (reflecting the decline in Covid vaccine uptake on the IOM).
74. It is also interesting to note that the commercial contract between the EU and Moderna was leaked to the press in 2021 and revealed that payment for Covid vaccines was to be made to Moderna's newly created Swiss subsidiary called Moderna Switzerland GMBH. This means that Moderna's Covid vaccine profits were subject to Swiss secrecy laws with little or no tax paid (a question about this specific tax issue was asked in the European Parliament on 5th May 2023).
75. This is particularly troubling given that these staggering vaccine profits and the little tax paid, is *in spite* of the billions of pounds of taxpayers' money

which was freely granted to drug companies to subsidise the initial development of Covid vaccines. They're laughing all the way to the bank!

76. It has also been noted with concern what is termed the "*revolving door*" of government employees leaving official positions only to join private businesses which operate in the same areas where the individuals were previously State employees. For example, Professor Jonathon Van-Tem, England's deputy chief medical officer, took up a role in May 2023 with Moderna as a senior medical consultant.
77. It is worth noting that Professor Van-Tem was a member of the UK Government's Vaccine Taskforce which made decisions on vaccine supply contracts, including the purchase of *77 million doses of the Moderna Covid vaccine*. There is no suggestion of any impropriety or illegality and Professor Van-Tem left his government role in March 2022. Although Moderna has insisted that the appointment was made in accordance with government rules for officials taking up jobs in the private sector, the perception of overlapping roles and interests persist.
78. It is also now in the picture that government bodies such as the MHRA actually receive fee income from pharmaceutical companies as well as money from entities which support vaccination such as the World Health Organisation. Interestingly, a UK Freedom of Information reply dated 31st January 2022 revealed that the *Bill and Melinda Gates Foundation* had donated \$3 million to the MHRA.
79. People are also increasingly asserting their human rights including bodily autonomy under *Article 8 European Convention on Human Rights* (right to respect for private and family life). In effect, "**My Body, My Choice**", and are refusing to be dictated to by government as to what is put in one's own body.

Conclusion

There is a choice whether or not to be Covid vaccinated, just as there is a personal choice to accept any other vaccine or pill or modern medicine. The important thing is that citizens are able to make **TRUE and INFORMED** choices.

Over the course of the last 3 years, people have gradually found out a lot more about Covid and Covid vaccines. This is in spite of, not because of, government messaging.

Many citizens now fundamentally understand that Covid is just a form of flu and that it can be treated appropriately. Covid vaccination has been revealed as being completely unnecessary for many people, it does not fully protect the recipient nor does it prevent the spread of the illness.

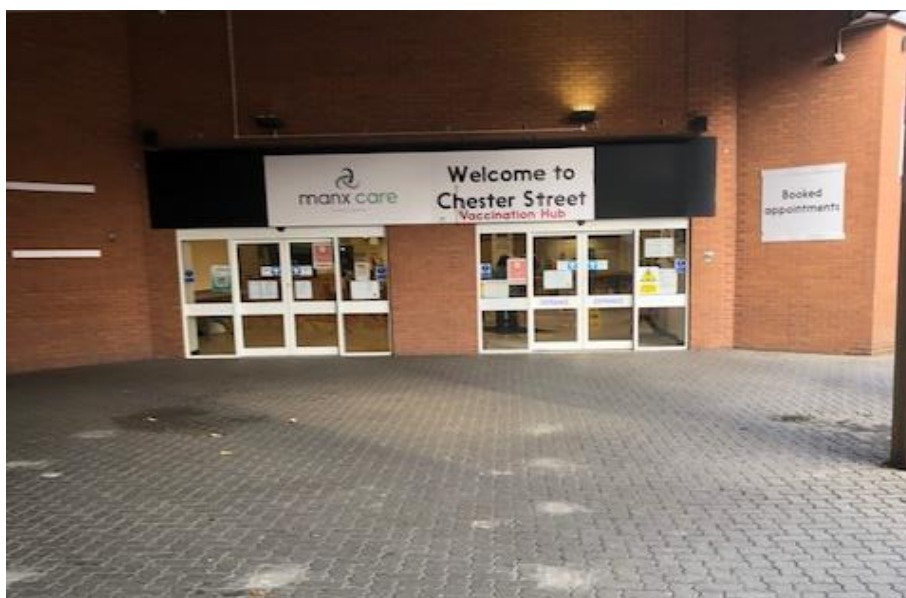
Persons are enlightened about the ingredients in Covid vaccines, their potential dangers and the harmful side effects. People have also wised up to the information

war which has been raging about Covid and Covid lockdowns, face mask wearing and associated compulsory vaccine requirements.

A health practitioner friend of mine recently summarised things by astutely remarking, **“There is no one who hasn’t been jabbed that regrets not being jabbed but there are plenty of people who have been Covid jabbed who wish they hadn’t”**.

Hence 71,849 persons on the Isle of Man agreed to have one Covid vaccination but **only** 6,245 have had a sixth dose.

Manx Care surprisingly announced last month that it is looking for a new Covid-19 vaccination hub to replace the facility at Chester Street, Douglas. It is claimed that the building is difficult to heat and lacks staff facilities (despite having been used satisfactorily for the last three years). But isn’t this an utter waste of taxpayers’ money if so few people now wish to be Covid vaccinated (unless of course the authorities know something we don’t)?
